With the locked gate, paved road, room for vehicles, it seems to be ideal, so why are you considering a new pumping station location at the end of Mariposa Court where families will be impacted financially and their wishes for optimal well being a major concern! We do not know the future, so what we can do today to assure the best results for tomorrow is most important! We are invested in what our neighborhood offers and ask that you understand with an open heart why we are here. Thank you
